Motion:

I move that the City Council enter a favorable recommendation on Oregon Liquor Control Commission (OLCC) Application No 08-106053.

Discussion:

On April 3, 2008, Truitt Brothers Inc. filed an application with the OLCC for a liquor license for property located at 556 Murlark Avenue NW. If approved, the applicant intends to use wine as an ingredient in food products.

State law allows the City Council to make either a favorable or unfavorable recommendation on liquor license applications. If a local government fails to make a recommendation within 45 days of getting notice of the application, under state law the local government's recommendation is deemed favorable.

Where there is no community objection, the City Council ordinarily takes no action on such applications, allowing a favorable recommendation to be entered by default. However, to expedite the overall processing time, the Applicant has requested the Council act on the application rather than letting the 45 day period lapse.

The West Salem Neighborhood Association Chair has reviewed the application and supports the Council expediting its ordinary process. By this motion, the Council will act affirmatively on the application, making a favorable recommendation, thereby shortening the overall OLCC processing time of the application.
