Dear Salem Property Owner/Resident:

C.R. Contracting has been awarded the contract for the construction of the 2020 Crack Seal Pavement Maintenance Project. The project will perform crack seal maintenance activities on one or more of the streets in your neighborhood (see enclosed maps). This project is based on available budget and there is no guarantee that all streets on the enclosed maps will be crack sealed. In the event your street is shown on the maps but is unable to get crack sealed, it will remain on the list for the next time the City has funding to complete additional crack sealing.

The work is scheduled to begin in July 2020 and be completed in September 2020. The exact date construction will begin in your area is dependent upon the contractor’s timeline. On the day the crack sealant is applied, the contractor will restrict street parking and close a portion of the lane(s) where they will be working. The Contractor will notify you via door hangers or “No Parking” signs prior to their work. Refer to the enclosed Frequently Asked Questions for additional information.

If you plan on being away from your residence for extended periods of time in July, August, or September, please ensure that no vehicles, boats, trailers, etc., are parked on the street. This will help the Contractor complete the work without delays.

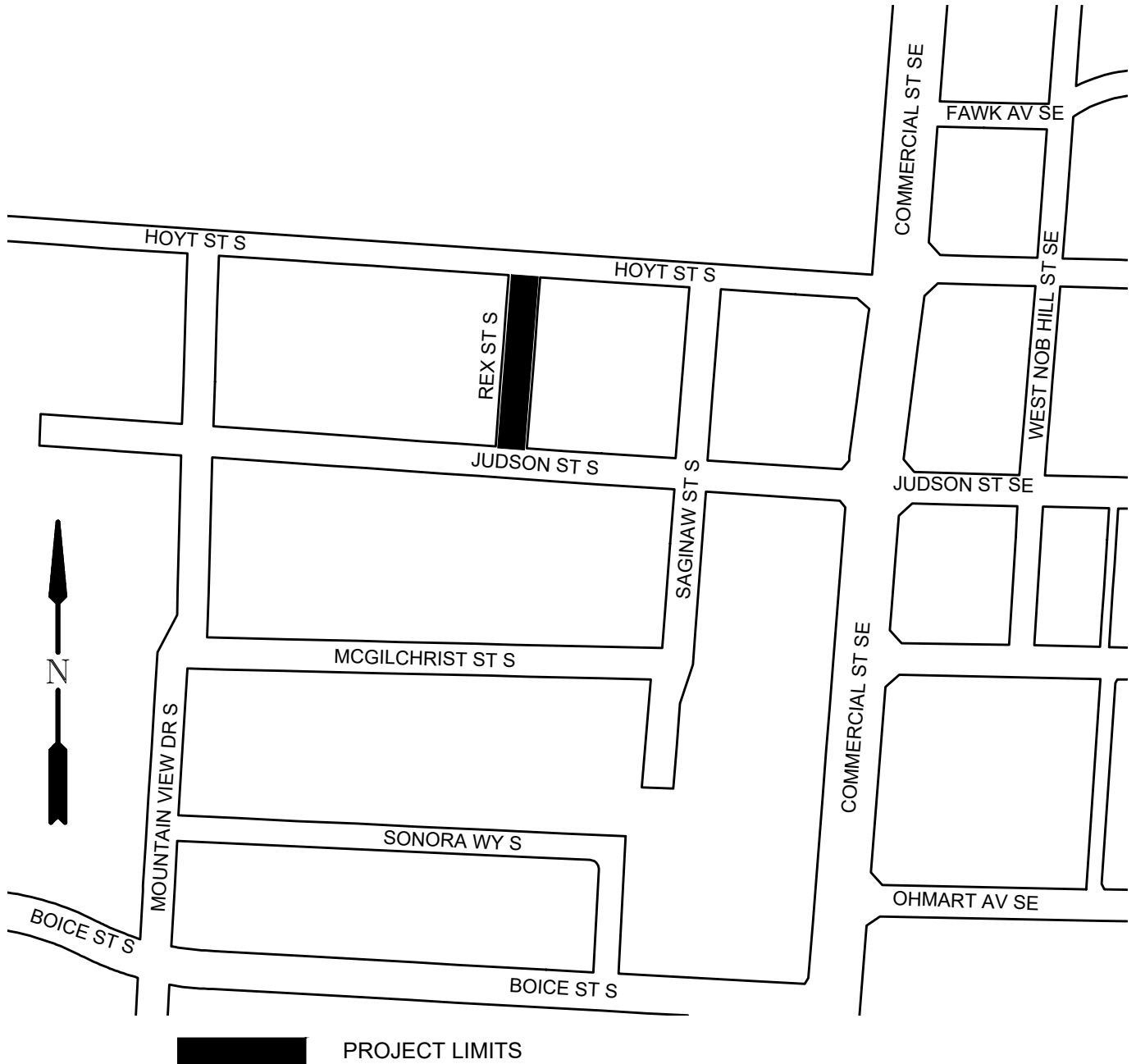
