Emery and Sons Construction Group has been awarded the contract for the construction of Secor Park Improvements. The project will include construction of a bridge across Waln Creek, a drinking fountain, paved paths, benches, and playground equipment. This project is funded with Parks System Development Charges.

The work is scheduled to begin mid-July with an estimated construction time of four months. To improve accessibility to the park, the Rock Creek Drive S and Stockton Avenue S entryways will be reconstructed. The park will be closed during construction activities. Please use caution when in and around the park and avoid the fenced work area.

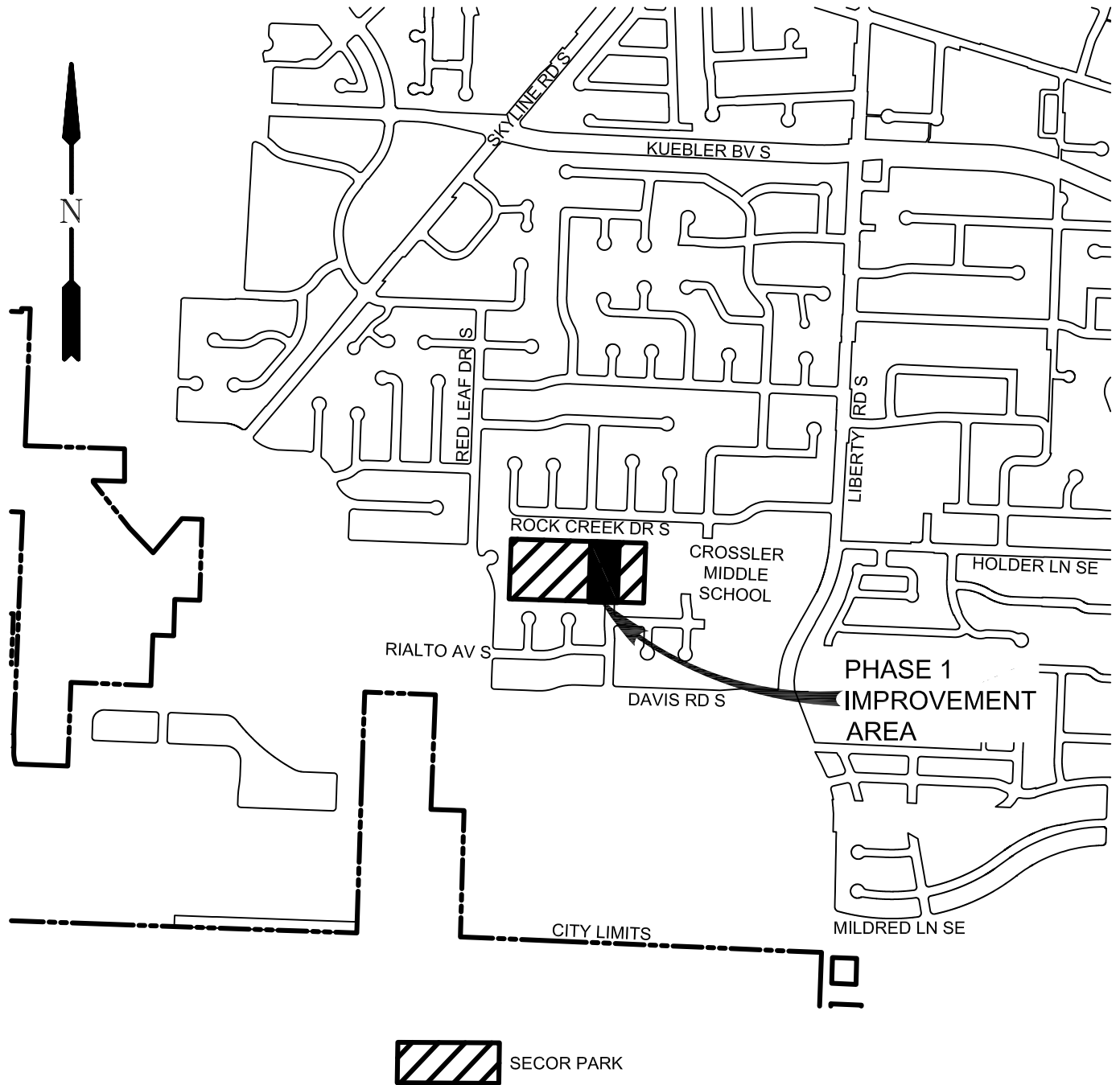
